1. UHI Updates

Senior Team

As flagged in our last meeting Neil Simco retired on the 31st July. An interim Deputy Principal (Peter Francis) had been appointed but unfortunately resigned for family reasons. From the 1st August Brian Williams (Dean of Arts, Humanities, Business, and Education) has been Acting Deputy Principal Academic and Research. David Worthington has become Acting Dean of Arts, Humanities, Business, and Education. A search process is underway to make a Deputy Principal appointment.

Two VP appointments have been made – Jane Lewis VP Strategic Projects and Nick Owens VP Research and Innovation.

2. Update on enrolment figures

We had a successful student induction period. This year, we held inductions in Lerwick, Scalloway and Mareel, with an online session also offered. It was positive to have a standardised approach across sites. We also offered drop-in sessions for enrolments with reasonable attendance. In addition we incorporated enrolment sessions within inductions to try to ensure that people completed their enrolments promptly and prior to attending so that they can access all their resources from the start of their studies.

Enrolment numbers for FE full and part time courses are strong for this point in the year and suggest a similar level of engagement to last year. It is encouraging to see continued demand for our local provision; however, we are constrained by our credit target for AY 2024-25 which remains at 3902, despite requests for this to be increased.

Based on performance over the last two years and the evidenced demand for 2024/25, it is almost certain that we will once again exceed our credit target by a substantial proportion, having overdelivered by around 25% in 23/24 despite implementing mitigating actions. In addition to the measures taken in 2023/24 to reduce reliance on credits, we will also be putting in place stronger costing principles for modern apprenticeships to allow a reduction in credits required, and we have secured external funding to cover some of the delivery that would normally be supported by credit income. Further, we have reduced the number of courses running for small cohorts, so that the additional cost of delivery to more students is lessened by classes being of reasonable volume.

It is still early to report on HE FTE numbers with the term having only recently begun and modules not yet being entered on student records. Our HE undergraduate 'home fee status' FTE target for 2023/24 is around 130 FTE and early indications suggest that we can realistically expect to achieve this target.

Update on Short Courses

We have been reviewing how short courses are promoted and applied for, and industry feedback has promoted consideration of the use of Eventbrite. A pilot has been successfully conducted and we expect a wider breadth of courses to be live on the platform from November.

We have been focusing recently on provision for the fishing industry, with a permanent staff member now trained to deliver the basic safety courses and a fishing industry open event planned for November.

There has been an increase in demand for courses linked to the launch of the new Workboat Code, with one company alone seeking three separate courses for each of their sixty Orkney based employees.

In the Health Care and Society Section staff members are delivering Mental Health First Aid, First Aid and Adult/Child protection to wider college staff team. AsStaff member is also delivering training 'Wir Ain Peerie Bodies' to early years setting across Shetland.

Simon Clarke and Edina Szeles offered short courses for Wool Week on the Prehistory of Clothing and Introduction to Weaving

Scottish Seafarms awarded a Heart of Community grant (up to £5k) for all NPA/SFW students to undertake boat training (Powerboat level 1) within their courses.

3. Update on Apprentices

For Skills Development Scotland (SDS) period 5 (April to Sepetmber), we had 54 new starts and so met our new starts target (51). We were only £500 short of our spend target £208,539 (target £209,043).

Our overall achievement rate has improved to 85% with 16-19 achievement rate increased to 76.9%

We had a successful SDS audit. Approximately 30 files were requested and the report came back with no actions required. We moved in one area from yellow to green so SDS were satisfied that we were complying correctly with processes. There was also a request via SDS from HMRC regarding ensuring that apprentices had employment status. From a sample of 5 apprentices, we came back with no actions required.

In the aquaculture section New MA/SVQ clients started – Bakkafrost, Organic Sea Harvest, Loch Duart and also MOWI MA/SVQ enrolments for Anglesey cleaner fish hatcheries – full fees

5. Update on merger related topics

Over the summer there has been work on a data sharing agreement with SIC education we hope we are very close to a conclusion to this.

We are continuing to have liaison meetings with SIC with excellent attendance and engagement at the last meeting.

6. Health, Safety and Wellbeing

- 3 accidents reported (2 staff and one student) one was a 1 RIDDOR.
- The Head of Health and Safety reported that lack of Facilities staff is increasing the H&S risk levels in the Lerwick campus and has pointed to this as the likely root cause of both RIDDOR accidents in the last 12 months. As both RIDDOR's occurred in relation to working under increased pressure due to working alone in the canteen, she recommended that staff are not permitted to work alone in the canteen for more than an hour.
- The college is still struggling to recruit the two empty positions in the Canteen due to current market forces.
- A part time Janitor for Lerwick campus, who is the replacement for full time Estate
 Technician has been successfully recruited and will officially start on the 1st of November. He
 is working as a casual for a few hours a week until then.
- Absence of First Aid Training is reducing the availability of First Aiders on our lists, as
 qualifications run out. However, a lecturer has now been recruited and dates for training
 staff are being arranged in November.
